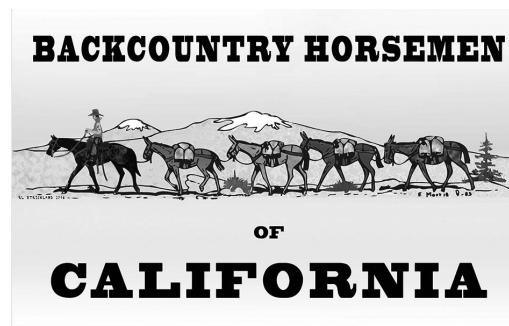

## MOTHER LODE UNIT RECEIVES 2018 DOUBLE DIAMOND AWARD FOR PONY EXPRESS TRAIL PROJECT

2018 marked the 50<sup>th</sup> anniversary of the National Trails System Act, so BCHC-Mother Lode Unit (MLU) partnered with the U.S. Forest Service (Eldorado National Forest) and the California Division of the National Pony Express Association to restore 47 miles of alpine trail between Pollock Pines (elevation 3,980 feet) and Echo Summit (elevation 7,382 feet). This section of the historic Pony Express (XP) Trail is located in a steep granite canyon carved by the South Fork of the American River and shares the narrow corridor with U.S. Highway 50.

Several trail features needed attention and were included in the project, each of which required special skills and equipment beyond the usual sawyer work MLU performs every spring. In these instances, MLU called on friends from other trail organizations in the region to assist and advise volunteers in developing a variety of new skills (trail rerouting, ford building, grading/gravel install and rigging/tackle techniques). Such technical assistance and special equipment came from individual members of Elegant Ears Mule Association, Tahoe Rim Trail Association and Pacific Crest Trail Association.

XP Corral Trailhead - First priority was the restoration of the XP Corral Trailhead near the midpoint of the 47 miles to provide a staging area for work parties and public access to the trail. This feature was functionally completed in 2018 (stump removal, grading for erosion control and surface hardened with gravel). The finishing work remains to be completed after the 2018-19 winter snowmelt.

Youth and Public Education - As soon as the trailhead was functional again, Boy Scout troops were invited to learn trail maintenance skills and Leave No Trace practices. In July, Troop 466 from Sunnyvale, California, pruned vegetation and added trail markers. In August, Troop 186 from Elk Grove placed riprap (cobble stones) in five erosion sensitive areas around the trailhead, three of which protected the seasonal creek. Troop 186 returned in October to finish a sixth area of riprap and clean culverts on 12 miles of the trail they adopted. One of their Eagle Scout candidates is creating a trail map for the United States Forest Service (USFS) to distribute to trail users as part of a new USFS Recreational Opportunity Guide (ROG) for the Pony Express Trail.

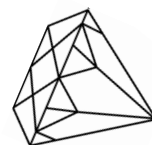
Kyburz Ford - A recent wildfire denuded the mountain above Kyburz, California, such that the severe winter of 2016-2017 caused a massive debris slide to totally destroy a trail bridge, which closed about four miles of trail. The USFS estimated replacement of the bridge would cost \$70,000 and would take several years to implement. As a substitute, environmental approvals were expedited to allow relocation of the trail 150 yards upstream to a spot suitable for construction of a ford.

Monster Log Removal - Every winter, trees fall across the single-track trail on hillsides that frequently slope at 30 to 45 degrees, with vehicle traffic below. A few of the trees exceeded 3-feet in diameter and required special equipment and training to cut and remove a half-ton piece from the trail without allowing it to roll down the hill into U.S. Highway 50 traffic.

One such log appeared on the XP Trail just east of Pollock Pines and caused closure of one mile of the trail. Using grant funds, MLU bought a 32-inch chain saw and some rigging equipment (cables, winches, pulleys, etc.) and conducted training on November 1. The 40-foot-long log was successfully cut where its 4-foot diameter trunk blocked the trail. All three pieces remained stable on the hillside and the cutout piece was parked off the tread so that only a minor S reroute was needed around the cut ends of the log.

Volunteers - MLU volunteers always work hard but 2018 was especially strenuous. They provided XP Trail improvements valued at more than \$142,000 in addition to their usual annual trail maintenance commitments in the El Dorado National Forest and packing support for Desolation Wilderness work crews.

Funding - The XP Trail volunteers were financially supported by cash donations from XP-CA and BCHC-MLU, plus portions of three grants from the National Wilderness Stewardship Alliance (NWSA). These funds allowed MLU to purchase equipment and materials (mostly gravel) and to reimburse volunteers for mileage. The 2019 finishing work on the XP Corral Trailhead will come from another grant funded by Bass Pro Shops.



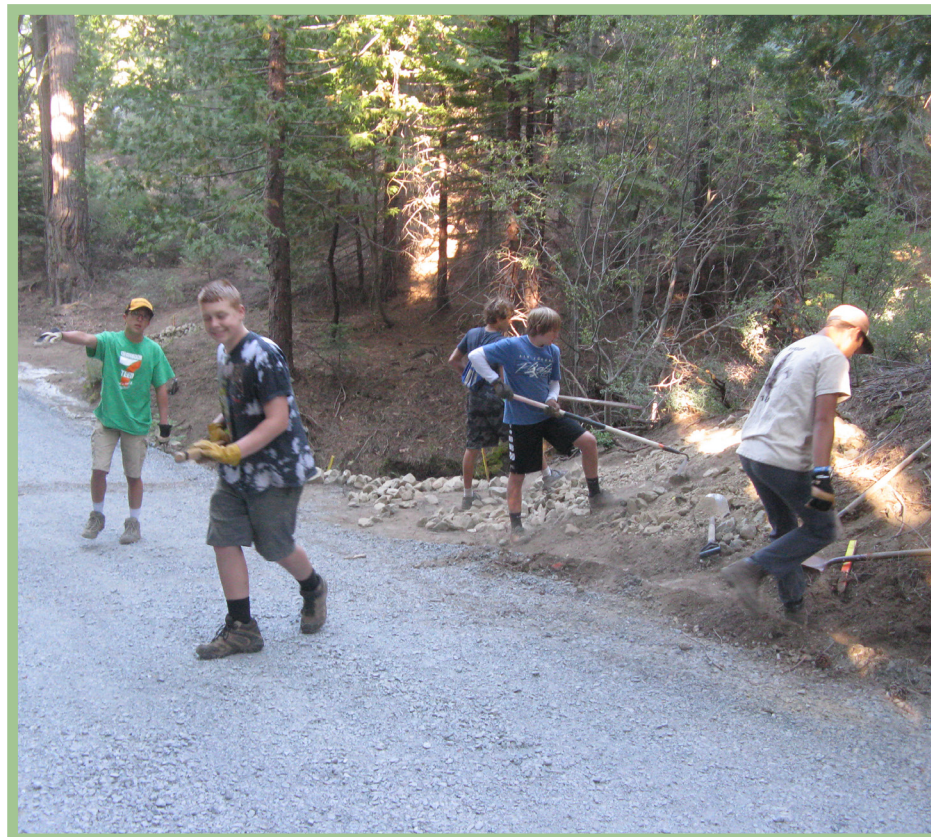

## PUBLIC LANDS UPDATE

On March 12, 2019, President Trump signed into law the Natural Resources Management Act (S47). This is a package of bipartisan public lands related bills that were passed in both the House and the Senate. It also is groundbreaking because it eliminates the need to return to these same topics year after year for approval and funding.

This bill sets forth provisions regarding various programs, projects and studies for the management and conservation of Natural Resources on Federal lands. It also renews the Land and Water Conservation Act which has been a focus for BCHC. The following is a list of some of the things this legislation covers:

- Land conveyances, exchanges acquisitions, withdrawal and transfers
- National parks, monuments, memorials, wilderness areas, wild and scenic rivers, historic, heritage sites, and other conservation and recreational areas
- Wildlife conservation
- Helium extraction
- Small mining waivers and claim maintenance fees
- Wildland fire operation
- The release of certain Federal land interests
- The Denali National Park and Preserve natural gas pipeline
- Fees for medical services in the National Park System
- Funding for the Land and Water Conservation Fund
- Recreational activities on Federal and some non-Federal land
- National volcano early warning and monitoring system
- Federal reclamation projects
- Search, rescue and recovery missions

Some of the areas this new bill covers in California include; The

Alabama Hills in Lone Pine designating the 18,000 acres as a National Scenic Area, The Santa Ana Land Wash Exchange in the San Bernardino area which will provide water storage and habitat, and California Desert Protection and Recreation Act which creates a system of Off-Highway Vehicle Recreation areas and expands some OHV areas in the California desert. It also adds and creates permanent wilderness areas on 375,000 acres of federal land, while releasing 124,000 acres that were wilderness study areas back to general use in the Cady Mountains and Soda Mountains regions. Other California areas in the plan include Joshua Tree, Death Valley, Anza-Borrego, Juniper Flats, and an area along the California-Nevada border.

This bill had widespread support from local governments, recreational groups and conservation groups. It is a model for how grassroots legislating should work as well as being a great example of bipartisan legislation.

On other matters; the Inyo National Forest held their Objection Resolution Meeting February 19-21. This is the process when persons or groups who filed an objection to the Report of Decision were given answers to their objections and the reasons behind the decisions. As far as I could find there is no new information on the Sequoia or the Sierra Forest's Plans. They are still working on their plans.

It is for this reason that we can only act on items that are listed on the agenda.

When Units have an idea, issue, fundraiser, suggestion, etc. that may affect or benefit all Units statewide and they want to get advice, approval, answers, etc. it is necessary to get the item on the agenda so it can be discussed and acted on. Please note - this is not for Unit issues, those should be resolved according to your Unit bylaws.

If you have an item that you feel could benefit or affect Units statewide, you should discuss the issue at your Unit meeting, and submit, in writing, the proposal and all backup data to the State Secretary ([bludog46@gmail.com](mailto:bludog46@gmail.com)). She along with the President will review the information and, if it meets the criteria of being a statewide issue, they will place it on the agenda. You will be notified by email if/when it will be on the agenda. Keep in mind that the agenda goes out 30 days prior to the meeting so get it to the secretary in a timely manner (a week before the 30 days is good).

Please be sure your Director is able to explain the item during the meeting and answer any questions that may come up. Or, if desired, another member could attend the meeting and speak to the item. Also, do not email information to Units on your own as it needs to come out on the official agenda so everyone gets the same information.

We know our members have some great ideas, and we want to hear them in a way that we can discuss them, vote on them and enact them if approved.

## **ALERT FOR ALL BCHC MEMBERS** **PLEASE TAKE ACTION**

There has been a new bill introduced into the U.S. House of Representatives. It is called the "Restore our Public Lands Act" HR 6510. It currently has 66 co-signers 5 from California – Cook, Castro, Panetta, Takano and Garamendi. This bipartisan bill allocates funds to pay for the high-priority deferred maintenance that is needed to support critical infrastructure and visitor service at our nation parks, wildlife refuges and other public lands. This backlog totals \$16 billion.

The fund would draw from all sources of federal energy revenue onshore and offshore, including alternative and renewable energy sources such as wind, solar geothermal and hydropower; as well as private donations.

As Backcountry Horsemen of California we all need to support this bill. We would also like to suggest that the bill be amended to include support for the Forest Service to address their maintenance backlog.

Please write, call or email your local Representative and tell them you support HR 6510 and that you would like to see it include the Forest Service.

### DRIVER LICENSE REQUIREMENTS FOR TOWING HORSE OR STOCK TRAILERS

This Information Bulletin (IB) provides clarification regarding the operation of specified horse and stock trailers, and other vehicles which are subject to the requirement of holding a Class A commercial driver license (CDL) or a restricted Class A driver license (DL). Questions have arisen as to the applicability for a California licensed driver, who operates a vehicle when towing horse or stock trailers with a gross vehicle weight rating (GVWR) or a gross vehicle weight (GVW) of more than 10,000 pounds, to meet the requirement of obtaining or holding a Class A CDL.

The following California Vehicle Code (CVC) sections classify DL and CDL requirements for California residents when towing horse or stock trailers in excess of 10,000 pounds GVWR or GVW.

**Class A CDL:** Section 12804.9(b)(1)(A) CVC allows the operation of a combination of vehicles when the vehicle being towed has a GVWR or GVW of more than 10,000 pounds. Most horse, stock, and other trailers may be operated using this class of license.

**Class A Restricted (noncommercial) DL:** Section 12804.12(a) CVC allows the operation of combinations of vehicles with a **restricted** Class A DL, also known as a noncommercial Class A DL, when towing a **trailer coach** exceeding 10,000 pounds GVWR, and a **fifth-wheel travel trailer** exceeding 15,000 pounds GVWR, when the towing of the trailer is not for compensation (**not for-hire or commercial use**). This DL is **not applicable** to horse and stock trailers. Additionally, Section 12804.14(a) CVC allows the operation of combinations of vehicles with a **restricted** Class A DL when towing a livestock trailer exceeding 10,000 pounds, but **not exceeding 15,000 pounds** GVWR or GVW, if **all of the following conditions are met:** the vehicle is controlled and operated by a **farmer**; the vehicle is used to transport livestock **to or from a farm**; the vehicle is not used in the operations of a common or contract carrier (**not for-hire or commercial use**); and the vehicle is used **within 150 miles of the person's farm**. This DL is **not applicable for recreational use**.

**Class C DL:** Section 12804.9(b)(3)(F)(ii) CVC allows the operation of combinations of vehicles with an endorsement (shown as a restriction 41) when towing a **trailer coach** exceeding 10,000 pounds GVWR, and a **fifth-wheel travel trailer** not exceeding 15,000

## BCHA NATIONAL BOARD MEETING

Dennis Serpa and I attended the BCHA National Board Meeting held in Asheville, North Carolina, in April. It was a three-day meeting for the board of directors (two from each state) to ensure BCHA is an organization you can be proud to associate with.

### Report on 2019 BCHA National Board Meeting - Committees

I will be reporting on the 2019 BCHA National Board Meeting in several articles this year. I have a lot to share and I do not want to confuse you with a very long-winded article trying to cover everything. So here is your first installment.

#### BCHA Committees

The meeting before this one, held in Spokane, Washington, was the start of a movement to greatly improve the effectiveness of BCHA through the committee process. In the past, items were discussed at committee meetings during national board meetings, though there was little follow-up by the committees and therefore little would get accomplished. So, following that meeting there was an improved amount of activity at the committee level and work continued during the year by members of those committees.

There also have been some changes to the missions and structures of the various committees, and some elimination. For example, the Public Lands Committee was restructured this year as follows:

#### Role of the BCHA Public Lands Committee

1. The Public Lands Committee exists to work on public land issues as they pertain to the five principles of BCHA.
2. The Public Lands Committee will assist the BCHA state organizations when called upon to help with public lands issues. Public lands are defined as all publicly owned lands not just federally managed lands.
3. The Public Lands Committee will provide the state organizations with the resources and education to help them better understand how to deal with public land issues.
4. The Public Lands Committee will promote cooperation with all public land managers, as well as with those organizations with whom we share a common interest.
5. The committee shall help screen issues coming from states and recommend those issues that could have regional or national precedence or require response from the national organization and pass those issues on to the Director of Public Lands and Recreation.

#### How the BCHA Public Lands Committee is organized

1. Communication is very important for the public lands

committee to be successful.

2. There shall be one chairman of the public lands committee, who is responsible for the functions and duties outlined in Governing Policies 4.12.7.
3. The chairman of the Public Lands Committee and the Director of Public Lands and Recreation will work together to ensure that the Public Lands Committee is working to best serve the members of BCHA.
4. The United States shall be broken into regions. The regions will be primarily based on Forest Service Regions but other factors will be considered.
5. Each region shall have a chair. The regional chairs will report to the chair. The states in each region shall have at least one member each on their regional public lands committee. Each region shall work with its members on local and regional public lands issues.
6. Each month the regional public lands chairs will meet with the BCHA Public Lands Committee chair on a conference call. The purpose of the meeting is for the regional chairs to share what is going on in their regions with each other and to influence as a group which items BCHA should be handling as opposed to being taken care of at the local level. It also is a time for the BCHA public lands chair to share with the regional chairs what is going on with public lands that they should be aware of and pass on to the rest of their committee. Communication is everything.
7. Regional public lands groups are encouraged to meet on a monthly basis.
8. A member of the Public Lands Committee does not have to be a member of the BCHA National Board.

#### Starting Point for Splitting BCHA into Regions

Far West Region - WA, OR, ID, CA, AK

South West Region – NV, UT, AZ, NM

Rocky Mountain Region – MT, CO, ND, SD, WY

North East Region – MO, IA, KS, MN, WI, IL, MI, IN, NY

South East Region – AL, GA, FL, SC, NC, VA, TN, KY, AR

This is just a starting point for the regions. Any state may decide to participate in a different region contiguous to itself. This is a living list and may be changed at any time.

## SUPPORT SB 415 - TOWING LAW

### We need to change our transportation law in California regarding towing of horse trailers.

**Please help to change the law!**

Currently, any of us towing a Horse trailer that has a gross weight rating in excess of 10,000 GVRW pounds requires a COMMERCIAL CLASS A licensed from the DMV.

GVRW is what the trailer is capable of carrying, not what it actually weighs. Most all of us with a LQ trailer and Class C license is in violation.

Good news there is some legislation that is moving forward to increase the limit to 15,000 GVRW with a Class C and a written test. We are suggesting that everyone that tows horse trailers to contact their local congressman and tell them you are in favor of SB 415.

Jennifer Stock is the new acting head of interpretation at Point Reyes National Seashore. She recently sent out the following bit of information about Stewart Horse Camp:

“Since late 2018, when the former operator notified the National Park Service (NPS) they would no longer be operating the Stewart Horse Camp within Point Reyes National Seashore, the NPS has been working to coordinate the continued seasonal operation of the Horse Camp without an interruption of visitor services. The NPS is in the process of obtaining approval for a temporary concession contract, including identification of qualified operator, which will allow services to continue while the NPS develops the longer term contract for operations at this site. The NPS anticipates operations under the temporary contract to commence sometime in May 2019”

## CORDELL BANK STAFFER STEPS IN AS POINT REYES NATIONAL SEASHORE SPOKESWOMAN

When John Dell'Osso retired in March from his decades-long post as chief of interpretation for the Point Reyes National Seashore in March, an employee from the Cordell Bank National Marine Sanctuary—which has an office across the creek at the Bear Valley Visitor Center—stepped into his shoes for an interim period. On an interagency detail, Jennifer Stock, who has served as an education and outreach coordinator for the sanctuary for the past 18 years, has taken over the role of translating all of the park's happenings for the public through Sept. 30 while the park looks for a permanent hire. Ms. Stock, a Petaluma resident, started her career as a seasonal interpreter for Fire Island National Seashore in New York and Assateague Island National Seashore in Virginia. “I've spent a lot of time on the water, hiking and enjoying the park. Since I started my career in the park service, this feels like coming home,” she told the Light. “The sanctuaries in the water off Point Reyes already work collaboratively, but this is great for encouraging interagency collaboration, so we can learn more about each other.”

## SAW PROGRAM

On the Monday after Rendezvous I was in Sacramento for the Annual Region 5 Saw Meeting. This was my 3<sup>rd</sup> year representing BCHC at this invitation only meeting. Present was every Forest Saw Coordinator for Region 5 and 4 Co-Operator Groups. Has taken a few years, but our acceptance at this meeting is starting to result in more cooperation with the Forest Coordinators.

Pete Duncan the National Saw Coordinator opened the meeting with an update on the restriction put in place last year by WDC Office not to buy any more Stihl chainsaws because of concerns with fuel geysering. The moratorium to purchase was put in place so as to not add anymore to inventory while a solution was being researched. There things such as vaporless fueling systems that are being tested. What was learned is that there is no real solution. All fuel containers can geysers under the right conditions and the factor of the current fuel blend. The big issue with Stihl Saws is the quarter turn fuel cap. There are some alternatives that are being worked on, but nothing final yet. There are no restrictions on use, only purchase of new ones.

This led into an hour long presentation by the Factory Reps from Husqvarna chainsaw. They were presenting their newest GEN3 Autotune 500 series electronic saws. Ergonomically these saws have really come a long way. With everything from outboard clutches to electronic carburetors and an elongated chassis.

Pete Duncan announced that Missoula Technology Development Center is working on a new saw curriculum that is slated to be out 6/2020. Retirement of personal and personal leaving the Forest Service have slowed the process down.

There was some discussion about JHAs and their need to address the particular project and not necessarily the hazards particular to the tool used on the project. We need to look at the Risk Assessment of the uncontrollable elements of each project and that this risk be covered in the Tailgate Session at the start of each work day. Making sure our folks have the proper training before beginning any work project or activity shall ensure volunteers are able to identify and manage potential risks and basic safety and health precautions of which they should be aware in order to perform the work safely.

The National Sawyer Data Base has been held up by Homeland Security and will probably be another year before it is rolled out.

Chip and I will be adding some new information to the BCHC Web Site Safety Tab. There is an updated FSH 6709.11 Health and Safety Code Handbook out. We know how you Cowboys enjoy reading Government Guide Handbooks, so we will be extracting the portions that most commonly apply to the tasks we face. Please take a look.
