



## NEW STUDENT PACKER COLLEGE FUND

Many of you already know that the UC Davis Pack Team is sponsored by the Mother Lode Unit (MLU) and that MLU is very appreciative of the team's stellar efforts at the Mule Days Interscholastic Pack Team Competition each Memorial Day weekend in Bishop, CA:

World Champions in 2016, 2017 and 2022 Reserve World Champions in 2013, 2014, 2015, 2019 and 2021 (Note: Mule Days was cancelled in 2020 due to COVID restrictions.)

To further promote the learning of packing skills among students, MLU and the UC Davis Department of Animal Science have cooperated to establish a fund for members of the UCD pack team(s). This fund is based on financial need and may be awarded each spring term upon formation of that year's pack team(s) for UC Davis.

We have avoided using the term "scholarship" because that is limited to undergraduate students and we want to include graduate students, so UCD advises the use of the term "student award." Donors to the student award fund can participate at three levels, all of which are tax deductible. - 1. Endowed gifts starting at \$50,000 and are donated directly to UC Davis.
- 2. Current-use gifts starting at \$5,000 per student award and are donated directly to UC Davis.
- 3. Gifts of any amount may be made to the BCHC Education Fund via the Mother Lode Unit. They will be provided for smaller student awards or combined for a larger award by UC Davis.

In addition to this new student award fund, MLU provides the UCD team with a packing trainer, uniforms, equipment for practicing, and travel expenses to Bishop Mule Days each Memorial Day weekend.

UCD and MLU have the capacity to train and support two four-person teams at Bishop Mule Days (one with blue shirts and one with gold shirts – the UCD school colors). These eight students plus two fully trained alternates will be eligible for financial assistance from the fund. 

**LEGISLATION** - The biggest problem we dealt with this year was California State AB 233. This was a proposed law that would have required all horses and mules ridden or used anywhere in the state be fitted with manure bags (often called bun bags). The rider would then be responsible for removing the manure and taking it to approved disposal sites.

The law would have given full authority to the governing agency to decide whether to enforce it. It included land owned by city, county, state and included any public land in the backcountry governed by the State. This is STATE land only and does not include National Forests, National Parks or Bureau of Land Management. This bill was pushed through quickly and went to Committee as soon we found out about it. I spoke about it at the BCHC Board of Directors meeting in February and was able to quickly get an email blast out to all members and others to immediately write to their State Assemblyperson and ask them to vote NO.

Thanks to the quick action of our members and other horse owners, we were able to have the "public lands" part of the bill removed! It will be heard in the Assembly on May 3, and hopefully does not pass, but if it does it will only apply to streets and sidewalks, if adopted by an agency, city or park. This is why it is so important to have correct email addresses of BCHC members. Right now, we only have emails for about half of our members. Email blasts are the only way we have to get information to all our members quickly, without having to wait until a meeting is held. We do not use or share our email addresses; they are only used to notify you about urgent matters. I would urge you to update your email address, or, if we do not have one for you, give it to our VP of Membership, Chip Herzig, so that you will be notified of important information.

## **Ann Lange Award**

This award was created to honor Ann Lange who worked tirelessly for BCHC in the area of Public Lands. Ann never met a stranger and was willing to go anywhere and talk to anyone about public lands. We received nominations for four great candidates this year and the judges thought long and hard to decide on a winner. Our winner was Marily Reese from High Sierra Unit. Marily was nominated by her unit and Bob Herrick wrote the letter. His detailed letter was a big part of why Marily was chosen.

Marily Reese – Nominee for the 2023 Ann Lange Award

Marily has been involved with the Backcountry Horsemen for the past 30+ years. Initially, she began working on stock user education programs in conjunction with her position as the Assistant Recreation Officer on the Sequoia National Forest. In addition to her Forest Service responsibilities working with the Backcountry Horsemen, Marily was actively involved with the Board of Directors for the High Sierra Unit. She was very committed to the education programs for the BCHC, including being a member of the initial Education Committee which developed the "Gentle Use Program," and working on numerous Rendezvous committees to schedule the education clinics. She also is an integral member of the Public Lands Committee.

Marily received her bachelor's degree from UC Davis, and worked for the Forest Service for 20 years in several locations throughout California. Forests she worked on included the Inyo, the Mendocino, the Sierra, and the Sequoia. Her career was focused on working in Recreation – including wilderness, trails, campgrounds, and special uses administration (working with resorts, pack stations, ski areas, and youth camps).

In 1997, she changed career hats and started a consulting business working with recreation resorts and businesses that operate on national forests and national parks. Marily's business serves as a liaison between the small business owners and the agencies that govern their operations. Over the years, Marily has been involved with numerous land management and wilderness plans throughout California – helping to provide input as to the effects the plans would have on the use of saddle and pack stock use for riding, packing and camping on those public lands. She continues to be involved with the Public Lands Committee of the High Sierra Unit.

While serving on the Public Lands Committee she has been in a leadership role helping to guide us through the evaluations of the Sequoia/Kings Canyon Wilderness Stewardship Plan Implementation, as well as providing comments on the draft forest plans for both the Sequoia-Kings Canyon (SEKI) and Sierra National Forests. Thanks to her leadership we have been able to develop a rapport with the Superintendent of SEKI, and she regularly attends our status update meetings with Superintendent Jordan and his staff. She assists us with our annual review of the grazing and stock use restrictions for SEKI, providing comments on how we can reopen closed meadows and make the backcountry more accessible to private stock users.

M.H. Reese & Associates is the name of her business, and she operates from her home base in Woodlake.

Marily is still committed to working with organizations for private and commercial stock users to keep trails open on our national forests and parks. I proudly support her nomination as a recipient of the Ann Lange Award. No one is more deserving. Thank you for your consideration.

This year Lynn Joiner from the Kern Sierra Unit was awarded the prestigious Ben York Trailblazer Award. Lynn helped in the formation of BCHC and even served as President for a term. She serves as our unofficial historian, our Chaplain, has been an asset at every Rendezvous and has been BCHC Treasurer for many years. It was a monumental task to keep this award a secret from Lynn, and she was extremely surprised when it was presented to her.

## **BCHC SAW PROGRAM**

The following is a letter I have sent to BCHC saw instructors and trainees:

To all instructors and trainees,

It's finally happened, on March 29th of this year the amended Forest Service Saw Policy was published. What does this mean? A number of things including a bucking only evaluator certification which means, we can now certify and recertify our own C instructors without requiring our evaluators to be fellers. Also, as a volunteer organization, we will no longer be using our own training but that of the Forest Service. It is arranged in modules 1 through 7. They will be used in a combination specific to whatever training is being done. We also have a new A and B evaluation sheet. Policy will no longer require an 8" high boot for non-fire but, just ones that are non-cut, lug sole lace ups that provide ankle support. There is also a provision for a B instructor that upon approval from the saw program coordinator that will be able to instruct and certify A sawyers. We also have been required to resubmit our saw program which has been submitted, signed by our R5 saw program manager and is awaiting the signature of the National Saw Program Manager. We will no longer be issuing or signing our own saw cards but instead the student evaluation information will be entered into a database, the card will be digitally signed by a line officer or someone designated for that task. And, the FS is requiring that it be done within 14 days from when the information is submitted. A pdf file of the card will then be emailed to the student. I am currently working on a new instructors file that will include everything needed to do a class. It will include the amended policy, training modules, student guidebook, instructors' guidebook, curriculum, a train the trainer section, and the new evaluation sheets. While we won't be required to make the transition to the new training until April of 2024, my goal is to be using it by sometime this summer or earlier if possible.


One more thing, Sarah Poncelow, this year's Rendezvous theme artist, came in second and she had just learned the hitch herself the day before.

Congratulations to all who helped and competed. You all made the packing events a big success. I look forward to next time.














Odd Load / Balanced Load (above) - Dan Baumgardner and Bob Herrick

Bridge on the challenging and scenic Trail Challenge course



## HIGHLIGHTS OF THE 2023 BCHA NATIONAL BOARD MEETING

- Expansion committee report Freddie Dunn. Motion to approve Texas to join BCHA, all approved
- Texas added as new state to BCHA.
- ☐ The new Texas directors brought from Senator Cruz an American flag that was flown over the capital of Texas to present to BCHA. Governor Abbott of Texas also gave the Texas Directors a letter to read to the National Board.
- On this 50<sup>th</sup> anniversary of the BCHA, there are now 32 states, 198 chapters, and 12,160 members.
- Committees reported out: Media, Membership, Education, Public Lands, Youth. In 2022, total value of BCHA Volunteer Hours was \$12,131.25.
- ☐ There were five resolutions presented. Two resolutions passed, three failed.
- Youth ad hoc committee requested its status to be changed from ad hoc to a standing committee. This was approved

- Six groups were developed to go over and update goals of the BCHA strategic business plan.
- ☐ Tuesday morning till lunch went over the history and development of BCHA. It started with four guys around a campfire.
- ☐ Tuesday after lunch the National Museum of Forest Service History gave a presentation on the new facility in Missoula, Montana.
- [] "Light on the Land" is a BCHA education program to compliment LNT covering stock use. It is not a take over.
- ☐ BCHA logo and BCHA anniversary logo are available to use on items. Go to the BCHA website for the policy and be sure to review the logo policy before using.

# 50-YEAR HISTORY OF BCHA PUBLIC LANDS\* Then (1973) to now (2023)

It all started with four men around a campfire

- **1973** Opposed horse permit system in the Bob Marshall Wilderness (MT) Began volunteer work program Flathead, MT
- **1979** Opposed explosive seismic testing in Bob Marshall, Great Bear, and Scapegoat Wildernesses (MT)
- **1981** Participated in the first national conference on public land use.
- **1982** Opposed all exploration in wilderness
- 1983 Opposed sale of Forest Service lands
  Countered trail closures due to false data claiming invasive species
  being spread by horses
  Opposed user fees to hunt in wilderness
- 1984 Endorsed Montana wilderness proposal
- 1986 Participated in President Reagan's Commission on the American Outdoors meetings advocated trail maintenance and public land access
- 1987 BCH members appointed to National Park Service's Stock Use Committee
  Prevented closure of Montana wilderness areas to stock use prompted by belief that horses were degrading water quality
- **1988** Supported new wilderness in Idaho
  First face-to-face meetings in Washington, D.C., with agency officials
- 1990 Supported Forest Service recommendation to remove outfitter caches in Frank Church Wilderness (ID)

  Appealed Forest Service management plan restricting trail maintenance in Cascades of OR and WA
- **1991** Supported Montana wilderness bill Recreational Trails Program (RTP) passes in Congress with BCHA support
- **1992** Opposed trail closures due to wolf and bear regulations

# USFS PACK STOCK CENTER OF EXCELLENCE APPRENTICESHIP INTERN PROGRAM

#### Summary:

The intern will be a corps member under the Eastern Sierra Conservation Corps (ESCC), a youth and young adult leadership and development program and will work directly with Forest Service Packers and Backcountry Horseman. This intern will be specifically trained in pack stock use, along with many other skills.

Back Country Horsemen of California (BCHC) aspires to support one Packer Intern each year. The intern will be located at the Center of Excellence (COE) in Mammoth Lakes California, as they are best equipped to teach the intern all of the goals that we in turn wish this program to achieve. In addition, the Center of Excellence provides consistent, professional staff that work directly with BCHC to accomplish our similar goals.

The mission of this program is to recruit and train an Intern that may become the new generation of highly skilled packer, trail workers, wilderness managers and volunteers that have a strong desire to protect our public lands, while preserving traditional wilderness skills and maintaining accessibility.

This is an all-inclusive training program in the use of pack stock as a traditional tool, humane stock handling and packing procedures. Mule and horsemanship as well as safety, are the cornerstones that this training is based on. Also included in the program is; Leave No Trace (LNT) practices for stock users, wilderness management, trail maintenance and all the details that go into a safe, productive and efficient, packing operation. Safety is integrated into all Pack Stock COE activities facilitating a culture of safety for both people and animals.

The Packer Intern will develop the skills and knowledge to help perpetuate the commonsense use of horses in America's backcountry and wilderness and will develop the skills and knowledge necessary to ensure that public lands remain open to recreational stock use; whether as an employee of the agencies, or as a private citizen.
