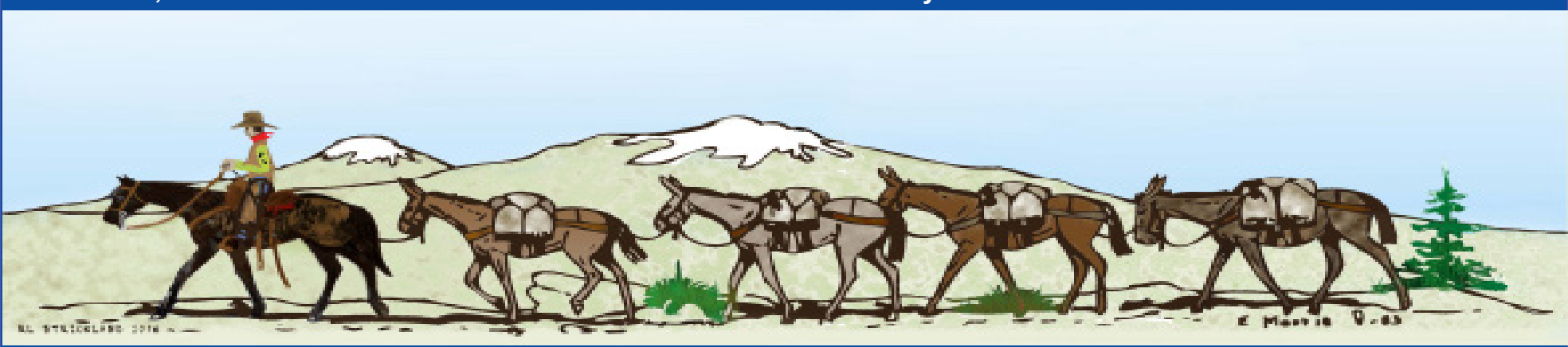

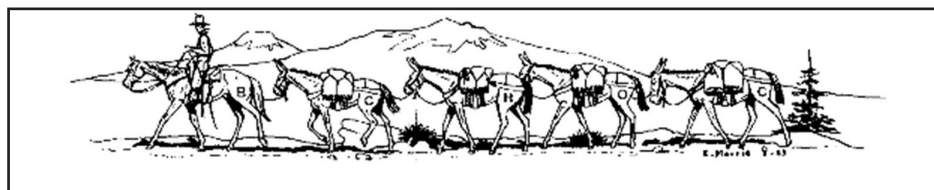

# President's Page

## THE BRAIDED ROPE

The other day I was out in the barn and grabbed an old reliable lead rope to use with one of the not so cooperative horses. As I pulled this tried-and-true lead rope through my calloused hands, I noticed it was becoming frayed in spots and was requiring a little TLC.

Upon reflection, the Backcountry Horsemen of California is also much like this handy rope - made up of many strands but strongest when braided together into one single unit. This invaluable tool is

flexible, capable, strong and adaptable. A lead rope is engineered to handle the stress of a large, sometimes cantankerous animal not always wanting to go where you are leading it. This well used and reliable rope was still more than capable of accomplishing its task. BCHC is this leadership rope, leading state of California BCHC units toward the shared goal of preserve, protect and maintain the back country and front country - this is our country.

Upon closer inspection I could not help but reflect upon how each individual rope fiber contributed integrity and tenacity to the strands, much like individual members within the BCHC organization. I noticed the beauty and precision of the smaller braids, much like the individual BCHC units, which, when blended, combine to form a strong and complete entity. When you take this thought to its logical conclusion, the committed individual BCHC members and units are interwoven together to form the state BCHC, along with the other BCH organizations nationwide. This is the strength and power of Back Country Horsemen of America.

Examples of this are as close as local unit projects. An example is the Sawyer Program that provides sawyer safety and training to ensure local trail maintenance. Each unit has a hierarchy of officers who rely on individuals assigned to set up tasks such as education, meetings, safety training, trail/meadow maintenance, trailhead cleanup, cabin rehabilitation/reconstruction, and everything else agencies and partner organizations come up with. Regardless of how many or where these tasks are, if members fail to show up then the assignments do not get done. We are only as strong as the combined talents of each member.

To balance these projects, let us remember not all gatherings have to be work related. In fact, we need to keep a balance of work, play and fundraisers foremost on our to-do lists. We not only accomplish great work, but we also form important fellowships, meet diverse personalities and, if lucky, form lasting friendships. One such incredible event is our own version of a country fair, only it's an equine fair. The highly anticipated BCHC Rendezvous, March 24 - 26, 2023 will be held in Temecula. ## UNIT SECRETARY DUTIES

From Backcountry Horsemen of California LEADERSHIP TRAINING AND RESOURCE MANUAL, Revised Jan 2022

- In coordination with the President prepare and distribute an agenda for each meeting.
- Report on all correspondence received or sent out. Answer all correspondence as directed by the officers as necessary.
- Maintain a sign-in list of members present at the meeting. Note any officers who are absent.
- After the meeting, prepare the minutes and share them with the President for review. File agenda, minutes and sign-in list in the secretary notebook.
- Read the minutes of the previous meeting and make any corrections as brought up. President should ask for approval of minutes. Note on minutes any corrections and the date of approval.
- When there is a motion on the floor write the name of the maker of a motion and the person who seconded the motion. Record the result of the vote (Motion carried – Motion did not carry). It is not necessary to put the vote count unless it is very close, and you are requested to do so.
- If the President and Vice President are not in attendance, the Secretary should call the meeting to order and motion that a chairman pro-tem be selected immediately to run the meeting.
- Complete any duties as assigned by the President and bylaws of the Unit.
- Maintain a notebook of all documents belonging to the Unit including, agendas, minutes, sign-in lists, treasurer reports, correspondence, bylaws, bylaw amendments, flyers, etc. Notebook(s) is to be passed on when your term of office is complete. If newly elected, you should seek this information from the previous secretary. All notebooks from previous years should be kept by the current Secretary to be turned over to the new Secretary at the end of their term.
- If Unit information is kept in a digital format, all information listed above should be copied to a thumb drive and that should be labeled by year and given to the next Secretary. It is recommended that the current year be kept on paper as well as digitally.
- Upon election the Secretary should become familiar with both the State Bylaws and your Unit bylaws. You should keep a copy available during all meetings.

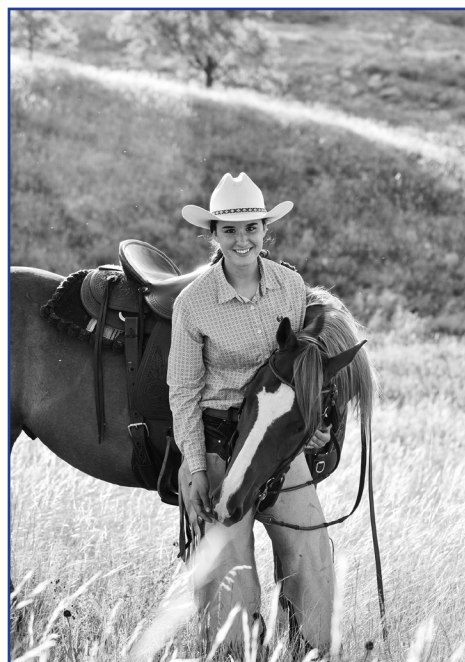

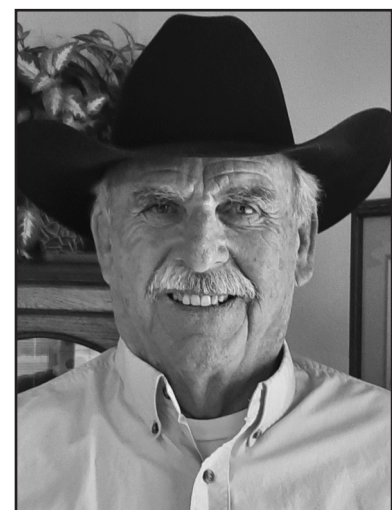

## BCHC VP OF PUBLIC LANDS

## INSURANCE

Greetings, Backcountry Horsemen!

As we head into the new year, there are a couple of updates about our insurance policy.

The new Event Request Form is now up on the State website, under Forms. Please fill one out and email it to me if you need an Additional Insured or Proof of Insurance for an event. It provides all the information I need to send to the agent without me having to go back through several emails. That enables me to send off your requests promptly so the certificates are returned in time for your events.

We also have the new Liability Release Form on the website; it's the one we approved at the October meeting. It is critical to our coverage that we all sign one of these forms before an event, both members and non-members. One bit of good news is that the company OK'd using one form with multiple signers for one event, so you can have people all sign one form (like on the back side) and not have to keep so many sheets of paper. Units must keep these forms from past events for three years, so it will streamline the process.



Hopefully we will all be able to get to the backcountry this year for rides and work projects! Right now it is either snowed under or washing away.

Please feel free to email me if you have questions about BCHC insurance.

## BCHC LIMITED LIABILITY INSURANCE

From Backcountry Horsemen of California LEADERSHIP TRAINING AND RESOURCE MANUAL, Revised Jan 2022

Our insurance is third party liability only. It does not cover members or their stock.

When is an Insurance Certificate required? An insurance certificate is needed:

- When the owner of a facility where a BCHC event is being held, requests the coverage it provides.
- When the owner of a facility or an administrator of a public property requests to be named as "coinsured".
- When the BCHC participates in any activity such as a BCHC group ride where nonmembers are invited to join the BCHC ride, a parade, fair exhibit, packing demonstration, work project, etc., where there is any chance that animals could make contact with anyone that is not a member of the BCHC. An Insurance Certificate is not needed for an event where there is no chance of the public being in the proximity of any of the animals such as meetings, dinners, parties, etc.

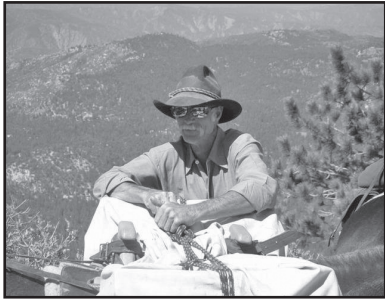

As we head into the new year there are a lot of changes coming to the BCHC Saw Program. But first, I would like to back up to last spring when I was contacted by long time BCHC member Ruth Gerson. Ruth said she had some old crosscut saws of her mother's that she would like to donate to BCHC. And, of course, I accepted. Then

began the problem of getting them. Ruth lives in Agoura Hills at the base of the Santa Monica Mountains and I live near the San Diego County line some 165 miles away. Well, after a few months of back and forth, Ruth said she could meet me in Temecula. We picked a day to meet for lunch and my wife and I finally got to meet Ruth. I really enjoyed our conversation and was able to pick up the saws. I have not been able to work on them but plan to soon. Thank you, Ruth, for making the effort to come down to my neck of the woods. My wife and I really enjoyed getting to know you. The following is an email Ruth sent after the exchange.

### 5 VINTAGE CROSSCUT SAWS

*On July 18, 2022, I donated 5 crosscut saws to BCHC. I gave them to Michael Lewis when I met him and his wife Pebbles in Temecula for lunch. He instantly knew the names of each type of saw. I am so glad that now people will use them for repairing trails by cutting the big trees that have fallen across trails. Although the saws are rusty, I know that Michael will clean them up. Some of the wood handles are broken and will need replacing. There are two 48-inch ones – two 72-inch ones – one 60-inch. These saws were my mom's, although I doubt she used them as she was a teacher, a musician and an attorney. She was born in New York in the early 1900s. I believe that the saws are over 100 years old. I would appreciate a note from BCHC acknowledging receipt of this donation.*

Now on to the Saw Program changes. The Forest Service has been working on some policy and curriculum changes. What does this mean for our program? Number one is a bucking only C-evaluator will now be an approved certification level. This is the certification needed to keep our "C" level instructors up to date and will no longer require a felling certification. We will also be using a new database to issue cards. This means that we will enter the students' evaluation information into the database and within two weeks a signed card will be available for the student to download. We will no longer issue or sign cards ourselves. Lastly, it appears the new FS training curriculum is complete and all cooperators will be using this new training which means we will no longer be using our own training. This is nationwide and will bring all saw programs in line with each other. We will be required to resubmit our program but it will now be just a one-page document. These changes as well as others will take some of the load off our program and I look forward to their implementation. There will be a Region 5 saw workshop held in Auburn in early March where we will have the opportunity to learn the new training curriculum.

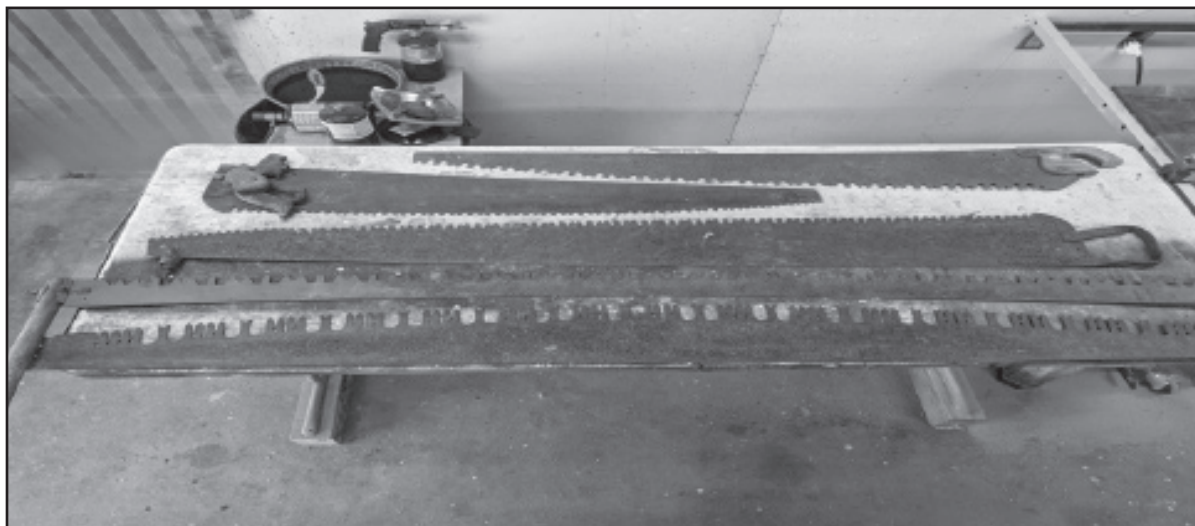

## ALAN T. HILL

June 5, 1938 - October 12, 2022

Longtime Redding resident Alan Hill passed away October 12, 2022, at age 84. Alan attended Shasta High School and the University of Nevada/Reno. He married Bev in 1963. Alan was self-employed and owned Trinity Hill Enterprises.

Alan joined BCHC in 1989 and, as described in the BCHA Lifetime Achievement Award (at right), held leadership roles in the Shasta Trinity Unit as well as at BCH state and national levels. Alan was a champion of public lands, wilderness, trails, and youth development. He was passionate about ensuring safe access to national forests; a passion that helped create the 30-year partnership between the USFS, BCHA, and CCC Backcountry Trails Program. Alan frequently spoke to funders, stakeholders and partners, attended meetings and lobbied for resources. He planned and packed-in state and USFS officials on VIP trips to show firsthand the important work CCC crews completed.

Alan served as Shasta Trinity Unit's Public Lands/USFS/CCC Coordinator, on the RAC Committee, as Work Projects Chair, and coordinator of countless successful fish plants. He welcomed his unit to hold activities and fundraisers at his Trinity Center ranch.

On the national level, Alan served one term as BCHA Chairman and for many many years as BCHA representative to the National Board. For years, he faithfully traveled to Washington, D.C., to represent BCHA at Hike the Hill events and served on the American Horse Council Recreation Committee.

As you can see by the photos included here, Alan was engaging, had a terrific sense of humor and a contagious smile. He was a true gentleman who will be missed by all who knew him.

Greetings! My name is John Marshall and I'm a member of the Mid Valley Unit in Modesto, CA. I would like to share about the John Wayne Pioneer Wagons and Riders in Washington State. The club has put on The Cross State Ride for 42 years. This year the ride will be held May 18 through June 4. It starts in Eastern Washington and ends in Tekoa, Washington, on the Idaho border

- a little over 200 miles. It sounds like it is overwhelming, but it isn't. We travel an average of 15 to 20 miles a day.

I have ridden 10 years in a row. The first year I had only ridden horses for 1-1/2 years. I rode my horse five years, packed one horse, packed two horses, packed three horses, drove my easy cart and, last year, I was a swamper on my friend Clarence's wagon pulled by his two mules. I have ridden with a 12-year-old girl that rode bareback the entire way; with 80-year-olds and every age in between. I've seen a 12-year-old boy ride his bicycle the whole way with his family. Last year an 80-year-old rode his bicycle the whole trip. I met a 60 to 70-year-old lady that walked 10 years in a row.

I have seen minis pulling carts, a six-up team pulling a stagecoach and teams of mules hitched to a shepherd's wagon. I've seen everything from wagons, buggies, surries and carriages to covered wagons on the ride. I think I have seen every breed of horse and mule. After completing this ride, every horse and mule is a much better partner and animal.

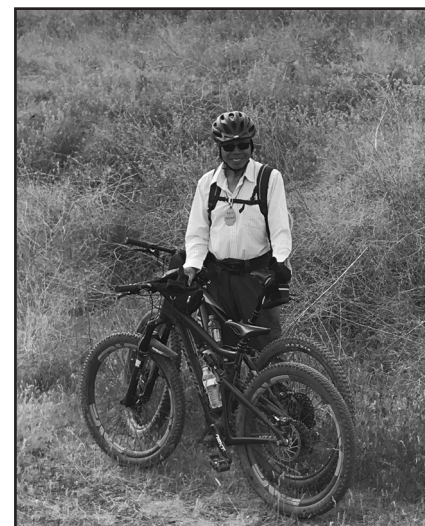
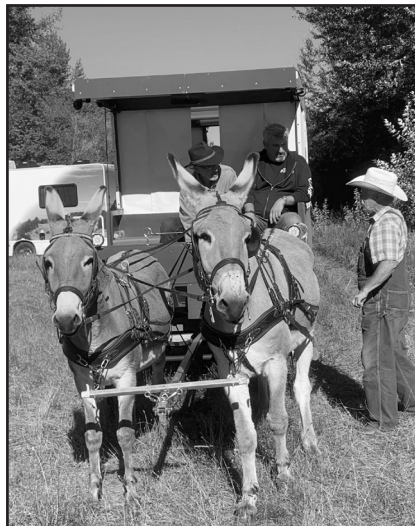
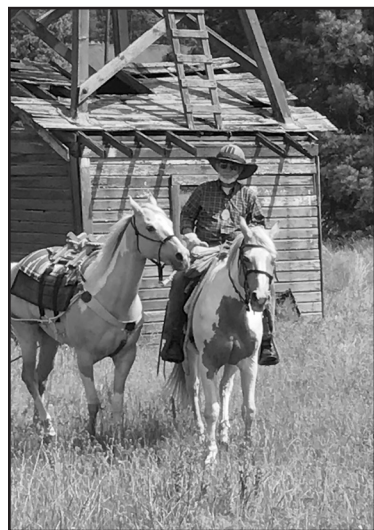

## REDWOOD UNIT:

### TEN BEAR WORK WEEKEND

In October 2022, several members of the Redwood Unit of Backcountry Horsemen set off into the Six Rivers National Forest in Humboldt County to build a set of corrals for an equestrian campground that they knew needed some work. Their sights were set on Ten Bear, a trailhead on the west side of the Marble Mountain Wilderness.

Going up, the team already knew there was damage to some of the corrals and spent their first day clearing debris with chainsaws and elbow grease. The first day they assessed most of the damage and fixed some small things like a rotting hitching post. The corner of one of the corrals was burned in a wildfire that had passed through the previous year, so they found some wood to replace it. They patched up all the fallen fencing and picked up wire that was found around the corral areas.

The second day, they turned off the water system for the winter and used the tools they had brought to cement-in the new corrals. The team brought up a welder, all corral panels needed for two corrals, hammers, nails, drills, shovels, a posthole digger, cement and some great attitudes.

On their way home, they checked out another horse camp in the area - Stanshaw - and fixed a couple of gates. They also found a spot that would be good to build an outhouse one day.

No stock was brought up on this trip, but the group left the spot for the winter knowing that using the new corrals in the springtime is just around the corner. A huge thank you to everyone who worked so hard on this project: Lori White, David Pritchard, Penny Calvo, Marsha Bradbury, Mary Moore and Billie Mohr.
